

## FREE PARKING PROMOTION OFFICIAL RULES

The following Promotion is intended for legal residents of the United States of America and D.C. only and shall only be construed and evaluated according to U.S. law and the laws of the State of Florida. Do not enter this Promotion if you are not located in the USA at the time of entry.

**SPONSOR/ADMINISTRATOR:** The “Free Parking Promotion” (the “Promotion”) is sponsored by the Charlotte County Airport Authority, 28000 A-1 Airport Road Punta Gorda, FL 33982, (the “Sponsor”) and administered by Punta Gorda Airport (PGD) staff.

**ELIGIBILITY:** The Promotion is open and offered to any adult age 18 or older at the time of entry. No purchase necessary. Void where prohibited. Only one submission is allowed per unique name AND email address during the entire Promotion Period. Up to two members of the same household may enter the Promotion. Winners that are not drawn the first month will automatically remain in the running for the following month’s drawing, until the promotion concludes.

**SUBMISSION PERIOD:** The Submission Period is October 1, 2021 through October 31, 2021 at 11:59 p.m. ET. and November 2, 2021 through November 30, 2021 at 11:59 p.m. ET. Additional Submission Periods may be added in 2022 if the Sponsor authorizes extension of the Submission Period.

**HOW TO ENTER THE PROMOTION:** During the Submission Period, Entrants can enter by filling out and submitting an online form. By submitting this form, Entrants are consenting to receive marketing emails from: CCAA, 28000 Airport Road, A-1, Punta Gorda, FL, 33982. Entrants may revoke their consent to receive emails at any time by using the SafeUnsubscribe® link, found at the bottom of every email. Emails are serviced by Constant Contact.

**PROMOTION PERIOD:** Drawings will be held November 1 and December 1, 2021 and may be extended into 2022 if the Sponsor authorizes extension of the Promotion Period. One winner will be drawn for each 10 unique submissions, up to 10 winners per month.

**PROMOTION PRIZES:** Throughout the Promotion Period, up to 20 certificates will be issued for “One Free Week in Long-Term Parking Lot” valued at up to \$66. Each certificate will expire on May 31, 2022 and/or must be redeemed by May 31, 2022.

**NOTIFICATION:** The winner(s) will be contacted and qualified (via telephone and/or email) by the Sponsor. Each prize certificate will be mailed via U.S.P.S. within a week after winner’s verification of name and mailing address. Each certificate will be filled out with the winner’s name and the name of the person that is redeeming the certificate (if different from winner, if winner requests it to be transferred at time of verification). Sponsor reserves the right to substitute the prize or any prize component with another of comparable or greater value.

If a prize or prize notification is returned as unclaimed or undeliverable to a potential winner,

if a potential winner cannot be reached or does not comply with the Sponsor's notification instructions within seven (7) days from the first notification attempt, or if a potential prize winner fails to return requisite verification within the specified time period, or if a potential winner is not in compliance with these Official Rules, then such person(s) shall be disqualified and, at Sponsor's sole discretion, an alternate winner may be selected for the prize at issue.

**GENERAL CONDITIONS:** If for any reason the operation or administration of this Promotion is impaired or incapable of running as planned for any reason, including but not limited to: (a) infection by computer virus, bugs, (b) tampering, unauthorized intervention, (c) fraud, (d) technical failures, or (e) any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Promotion, the Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Promotion in whole or in part, at any time, without notice and award prizes using all non-suspect eligible Entries received as of, or after (if applicable) this cancellation, termination, modification or suspension date, or in any manner that is fair and equitable and best conforms to the spirit of these Official Rules. Sponsor reserves the right, at its sole discretion, to disqualify any individual deemed to be (a) tampering or attempting to tamper with the entry process or the operation of the Promotion or Sponsor's Website; or (b) acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE PROMOTION IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH PERSON(S) RESPONSIBLE FOR THE ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW.

Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

**ADDITIONAL PRIZE CONDITIONS:** By accepting a prize, the winner agrees to release and hold harmless the Sponsor from and against any claim or cause of action arising out of participation in the Promotion or receipt or use of the prize. The winners will be responsible for all local, state, and federal taxes associated with the receipt of their prize.

**DISPUTES:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of Entrants and Sponsor in connection with the Promotion shall be governed by and construed in accordance with the laws of the State of Florida, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's or jurisdiction's laws. By participating in the Promotion, Entrant agrees that: (i) any and all disputes, claims, and causes of action arising out of or in connection with the Promotion, shall be resolved individually without resort to any form of class action; (ii) any judicial proceeding shall take place in Courts of Charlotte County, Florida; (iii) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this

Promotion, but in no event will attorney fees be awarded or recoverable; (iv) under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to seek, punitive, incidental, exemplary, consequential, special damages, lost profits, other damages, and/or any rights to have damages multiplied or otherwise increased; and (v) Entrant's remedies are limited to a claim for money damages (if any) and he/she waives any right to seek injunctive or equitable relief.

**SEVERABILITY:** The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. If any provision of the Official Rules is determined to be invalid or otherwise unenforceable, the other provisions will remain in effect and will be construed as if the invalid or unenforceable provision were not contained herein.

**MISCELLANEOUS:** These Official Rules contain the full and complete understanding with respect to the Promotion and supersede all prior and contemporaneous agreements, representations and understandings, whether oral or written. The headings herein are for convenience only, do not constitute a part of these Official Rules, and shall not be deemed to limit or affect any of the provisions hereof. No amendment to, or waiver of, any provision of these Official Rules shall be effective unless in writing and signed by Sponsor. The waiver by Sponsor of any provision of these Official Rules shall not constitute a waiver of any other provision herein. The rights and obligations hereunder may not be assigned by Entrant, whether by operation of law or otherwise, without the prior written consent of Sponsor, and any attempted assignment in violation of the foregoing shall be null and void. These Official Rules shall be binding upon, and inure to the benefit of, the permitted successors and assigns of Sponsor and Entrant.
